Scope

Our Privacy Statement governs any kind of processing where we are acting as a data controller or co-controller (including collection, use, transfer, storage and deletion) of personally identifiable information (any information that may be used to identify a physical person, and any other information associated therewith) about natural persons. This statement applies to our processing of data collected through any means, actively as well as passively, from persons located anywhere in the world.

We are guided by the following principles when processing data:

- We will only collect data for specific and specified purposes; we will make it clear at the point when we request your information, what we are collecting it for and how we are going to use it

INFORMATION COLLECTED

The information we may collect about you could include, but is not limited to:

- Your payment and billing information
- Any other documentation you choose to share with us

We can confirm that the data you provide to Bespoke Education Tutoring is held as securely as possible, bearing in mind no platform can be guaranteed to be 100% secure. Your data will not be used for anything other than the functioning of the services we provide. We will never give or sell your data to any third parties for any reason whatsoever.

The only times we will share your information are:

- 1. To disclose information in the case of a safeguarding issue, or
- 2. Because you ask us and give us permission to share your information with someone else

We hold your data until the contact finishes, when we will delete all electronic records and return any paper documentation to you. There are exceptions to this:

- 1. Any data relating to safeguarding, accidents or incidents you share with us must be held until the child turs 21 and 3 months of age.
- 2. Contracts, consent forms, information sheets, invoices and payments must be held for 7 years.

We may ask you if you would like to opt into receiving communication from us once the contract has finished.

We will collect information from you when:

- You post on our social media channels, website or blog

We may use the information collected to:

- Allow you to process a booking for tutoring sessions
- Send you our newsletters or provide you with information, products or services that you request from us or which we feel may interest you, where you have consented to be contacted for such purposes
- Ensure that content from our site is presented to you in the most effective manner for you and your computer
- Allow you to participate in the service you have chosen to do so
- Notify you about changes to our service
